§3 NM in Denmark 2016

DMF is arranging the NM in 2016 and DMK in 2020. After that the two clubs, DMF and DMK is arranging in alternate years. This agreement was signed by all the present club representatives.

§4 Membership in the Nordic cavy clubs

- Anyone can be a member in as many clubs one would like to. We agreed that if a
 person wants another main/head club, then in the person home country. That is ok.
 The person has to communicate to all involved clubs. The person can not change
 main/head club in middle of the year.

- Champion: The first champion titel could be taken in any Nordic country. The following titels can be taken with just one certificate (before or after the titel). You can register the one certificate champions your own country. Every country has an obligation to send the champion list to each club in the end of the year.
- We agreed on new titel Nordic champion, NordCH, with start 2016-01-01. You have at least three championtitels out of four to get the titel NordCH. We agreed to register the championtitels in each country. Every country has an obligation to send the champion list to each club in the end of the year.

§5 Rules for the Nordic shows, NM

- 1. We agreed about that the arranging country/club rules about showing classes and inchecking is the rules for the Nordic show. Sweden and Finland have to discuss at there yearly meeting 2015/2016 if they will allow Static lice in the Nordic shows with points taken during the judging. Report next Nordic meeting.
 We agree on that breeds with full standard in two Nordic countries is allowed to be shown at the Nordic shows as full standard. If there is any breed that is banned due to domestic legislation in a specific country, that breed is not allowed to be shown in that specific country at the Nordic show. The arranging country that is responsible the NM that year is responsible for updating all approved breeds that can be shown at the NM.
